Co-Chair

Currently filled by: Roy D

Sobriety Requirement Time: 2 years continuous sobriety

The co-chair shall perform the duties of the Chair in his/her absence and shall automatically assume the position of the Chair if the Chair resigns mid-term. The chair responsibilities include facilitating all Group Conscience and Steering Committee meetings. The Co-Chair is the co-custodian of all funds of the AAHG in coordination with the Treasurer, including overseeing the preparing, securing, and maintaining State and Federal incorporation documents and annual filing tax return, subject to approval by the GC. The co-chair is also part of the Grievance Committee which meets on an as-needed basis. This position is also encouraged to monthly Group Conscience meetings and attend bi-monthly Steering Committee meetings.

Secretary

Sobriety Requirement Time: 18 Months continuous sobriety

The Secretary shall keep an accurate written record of all Group Conscience (GC) and Steering Committee meetings including the postings of all Agendas and Minutes. The Secretary will post these records to the AAHG website as well as in the appropriate Telegram chats. The Secretary shall oversee the aaHG's email account and direct appropriate responses to members emails. The Secretary is also responsible for noticing any and all elections. The Secretary can also serve as an alternate to the OISR if they are not able to attend outside meetings. This position is also encouraged to monthly Group Conscience meetings and attend bi-monthly Steering Committee meetings.

Information Technology (IT) Chair

The Information Technology (IT) Chair shall provide strategies, suggest programs and support the mission of the aaHG. The IT Chair shall assist in maintenance of the Group's website, Zoom account, email accounts and Telegram accounts. This position is also encouraged to monthly Group Conscience meetings and attend bi-monthly Steering Committee meetings.

The OISR will also assist the group in solving a variety of problems, especially those related to the Traditions. Scheduling Chair

This position is also encouraged to monthly Group Conscience meetings and attend bi-monthly Steering Committee meetings.

The Security Committee Co-Chairs shall oversee the day-to-day security of the meetings and the training sessions for members volunteering as Hosts, Chairs, Security or Greeters. The committee is responsible for security on the Zoom platform. Group Conscience approved that the Co-Chairs should, when possible, be filled by one man, one woman or one no-binary member. If only men, women or non-binary members are nominated they may be elected to fill the seats. This position is also encouraged to monthly Group Conscience meetings and attend bi-monthly Steering Committee meetings.
